OFFICE ORDER

Date 20/06/2014

A financial grant of Rs. 16.80 Lakhs (Rupees Sixteen lakhs Eighty thousand) has been approved by the Competent Authority in favour of Kabiguru Industrial Training Centre (KGITC) for facilitating admission of 84 (eighty-four) Schedule caste (SC) Schedule Tribe (ST) and Below Poverty Line (BPL) candidates at KGITC in the trade of Plumber and Dress Making by paying a nominal fee of Rs. 1000/- instead of Rs.12300/- and Rs. 15200/- respectively including Hostel Charges (lodging) amounting Rs 7000/- (Rupees seven thousand only) per candidate.

The amount so approved should be released in two installments amounting Rs. 8.40 lakhs (Rupees Eight lakhs forty thousand only) in each installment. The amount of first installment amounting Rs. 8.40 lakhs (Rupees Eight lakhs forty thousand) may be released in favour of Kabiguru Industrial Training Centre (KGITC) through RTGS as per bank details submitted by Principal, KGITC.

Principal, KGITC shall submit the Utilization Certificate (U.C) and other relevant documents including details of admission of SC/ST and BPL candidates at KGITC within six months from the date of receipt of the 1st installment and on receipt of the same the amount of the second installment will be released. U.C. against the 2nd installment will be submitted within 6(Six) months from the date receipt of the amount mentioning about the admission of all the 84 (Eighty four) SC/ST and BPL candidates in the trades Plumber and Dress Making. The U.C. should be submitted in the prescribed format (copy enclosed) duly certified by a Practicing Auditor/ Chartered Accountant together with the details of the list of SC/ST and BPL candidates who have been given admission to KGITC for the trade of Plumber and Dress Making by paying a nominal fee of Rs. 1000/- only.

Principal, KGITC shall arrange to display a Board at the Training Centre where the SC/ST and BPL candidates will be imparted training, mentioning "A CSR Project of Coal India Limited for training of the SC/ST and BPL candidates" and a certificate shall be issued to each SC/ST and BPL candidate mentioning the scholarship being provided to them by Coal India Limited under CSR grant for undergoing training in the trade of Plumber and Dress Making.

The above sanction has got the FC No. 362-22 dated 19.06.2014 and B.C. No 2014-15/19061655 dated 19.06.2014 of Finance Division against Revenue Budget 2014-15






